If you have, since 6th October 2020 employed anyone who may qualify for Jobmaker, you need to just register now, before 6th January 2021. You can get more information later on and decide whether or not to claim. The point is that you register. This is done through the ATO Mygov portal. If you have problems the ATO can be contacted on 132866 from 8am Monday 4th January, 2021, keep a diary of your calls. The Ombudsman's report into the ATO handling of applications by small businesses for Jobkeeper and the Cash Flow Bonus shows that the ATO got it very wrong. Yet

the ATO have refused to correct their web site or contact businesses that are affected unless those businesses are already objecting.

Over 80,000 businesses so far have challenged the ATO successfully. If the ATO has denied you access to these payments on the basis you had not reported sales income before 31st December, 2019 then make sure you read this blog as there are many other ways to qualify other than just making sales.
