#### **ATO Scam Alert**

The ATO warns that it will never:

- send unsolicited messages asking for personal information to be returned through email or SMS;
- send an unsolicited email or SMS with a hyperlink, QR code or attachments;
- threaten immediate arrest;
- demand to stay on the phone until a payment is made;
- send unsolicited pre-recorded messages;
- ask for a fee to receive a refund; and
- prevent individuals from discussing their tax affairs with their trusted adviser or agent.

## **Update to Airbnb Blog**



The ATO have released a draft ruling TR 2025/D1 about holiday homes that are used for both private and rental income purposes. The ruling does not allow a tax deduction for any of your ownership costs such as rates, insurance, interest, depreciation, land tax, repairs and maintenance unless the property is mainly used to produce income. Mainly is not about the majority of weeks in a year. It also considers how the peak times are used and how genuine your attempts are to make it available for rent.
